WHY WILL WE CONTINUE TO MARCH?

Even with the wonderful blessing of *Roe v. Wade* being overturned, which allows more freedom at the state level to enact pro-life laws, the necessary work to build a culture of life in the United States of America is not finished. Rather, it is focused differently. Sadly, the number of abortions annually is still well over 900,000 each year, and that number is expected to decrease only by roughly 200,000 each year in a post-*Roe* America. Many national legislative battles loom, including even keeping longstanding Hyde protections, which limit government funding for abortion on annual appropriation bills. The Hyde Amendment has saved over 2 million lives and is arguably the most impactful pro-life policy in our nation's history, but now cannot be taken for granted. Last, our most important work is changing hearts and minds. The goal of the national March for Life is to not only to change laws at the state and federal level, but to change the culture to ultimately make abortion unthinkable.

With the role of the states being more important, we are also growing a strong state march for life initiative quickly, however, we will continue to march every January at the national level until a culture of life is restored in the United States of America.

COLUMBUS, Ohio— Today, Ohio Right to Life released its plan for the remainder of the year in response to the overwhelming pro-life victories in the election on November 8th, 2022. Moving forward into 2023, Ohio will retain its pro-life majority in the House, Senate, and the Governor's office. In addition, Ohio's Supreme Court will have a pro-life majority beginning January 2023.

Given this information, Ohio Right to Life finds it pertinent to pass legislation by the end of 2022 to effectively end all abortion from conception.

The following statement can be attributed to Ohio Right to Life's Chief Executive Officer, Peter Range:

“Candidates that support the pro-life cause won convincingly last night here in Ohio despite the left, including President Joe Biden, making abortion the centerpiece of their midterm election strategy. The people of Ohio have spoken clearly. They desire representatives with conservative principles, including the foundational conservative principle: the right to life!

Abortions Drop 6% in Two Months After Dobbs, Over 10,000 Babies Saved From Abortions

A new report in the New York Times shows abortions quickly declined after the Supreme Court overturned Roe. In just the first two months after the Dobbs decision in late June, abortions had already dropped 6% as more than 10,000 babies were saved from abortion.

That 22,000 decline in the number of babies killed was more than enough to offset the increase of 12,000 abortions in blue states that advertised abortions to women in pro-life states that protect women and children.***The data comes from a new organization called WeCount, which is led by the Society of Family Planning, a group that supports abortion rights. It is collecting abortion data from clinics, hospitals and telemedicine providers across the United States. It obtained detailed abortion counts from 79 percent of the nation's abortion providers, which were responsible for 82 percent of all abortions before the court's Dobbs decision. Researchers used adjustments based on state data and time trends to estimate the missing data. Note: The change in each month was calculated by comparing the number of abortions in the months after the Dobbs decision with a baseline number from April. The total cumulative change includes the change from both of those and a new national poll shows

[Polls show Americans are pro-life on abortion and a new national poll shows 75% of Americans essentially agree with the Supreme Court overturning Roe.](#) Despite false reports that abortion bans would prevent doctors from treating pregnant women for miscarriages or ectopic pregnancies, [pro-life doctors confirm that is not the case](#). Some [35 states have laws](#) making it clear that miscarriage is not abortion and every state with an abortion ban allows treatment for both.
