HELP US SPREAD THE WORD WITH THIS BILLBOARD

We have contracted for a 12' X 24' billboard (pictured above) to be placed for westbound viewing at Rt.6/ Rt. 24, Napoleon; the contract ensures against tearing and fading for up to one year. The generosity of donors to date has allowed us to secure this billboard space for an initial period of three months (June through August) at a cost of \$400/month. Further good news lies in our having opportunity to increase the number of display months with this contract. We can do that with additional donor support; PLEASE consider becoming a partner in making this happen through your donation to Henry County Right to Life Society.

A further prolife opportunity presents itself with a second/additional billboard contract for message placement on Rt. 6 near Northwest State Community College. This second three month contract opportunity offers an 8' X 20' billboard for lesser cost of \$350/month contingent upon signing for both contracts outlined here. Your generosity then, will allow us to consider extended months of display on our first contract as well as capitalizing on a reduced cost second contract thus adding to the strength of each dollar donated. Thank You to all who contributed to/signed our 2025 Pro-Life Signature ad published in the Crescent News and Northwest Signal in effort to shine a light on the tragedy of abortion and our unwavering and broad based community support of prolife efforts. A special mention of gratitude is extended to our church contact members who collected a total of 690 names representing 12 churches and 9 memorials. This marked the 52nd anniversary of the Roe vs Wade Supreme Court Decision and the more recent and welcomed (June 2022) Dobbs vs Jackson case which had the Supreme Court remove federal abortion as a right within the U.S. Constitution. Alongside all pro-life advocates, we are called to continue our efforts toward changing the many minds and hearts of those struggling to understand what modern science proves.....the sacred and separate humanity of life in the womb.
